Foundation. Through this initiative and others, we hope that you would consider sponsoring friends and associates of yours that you think would be worthy of Membership to our Foundation and its mission.



Q&A WITH CCF SCHOLARSHIP ALUMNI



VINCENT TOSCANO

College Scholarship Alumnus

Columbus Citizens Foundation Member, former Young Adults Co-Chair, former head of High School Scholarship Committee, Former Board Member

How did you first come into contact with the Columbus Citizens Foundation? What made becoming involved with the Foundation such a special experience?

Although I had received a partial academic scholarship from Hofstra University, it was the additional scholarship from CCF that afforded me the financial opportunity to attend. As my first exposure to the Foundation, it was a wonderful and unexpected eye opener. It really exposed me to a diverse group of highly successful and dedicated Italian Americans. Through

this introduction and interaction, it was reinforced that with enough hard work, anything is possible. Receiving the scholarship further instilled confidence in me, and coming from such an influential Italian-American organization made it even more special.

You became involved as a Young Adult and then a Member of the Foundation at a young age. Why was that so important to you?

My first encounter with CCF through the scholarship interview process was such a $formative\ experience -- I\ can\ vividly\ recall$ many of the questions (and my answers!) to this day. Upon graduating from college and embarking upon my career, I wanted to continue my relationship with this incredible group of accomplished business leaders by becoming a part of the inaugural Young Adults Auxiliary. My father had a strong work ethic which he instilled in me; so even at a young age, while developing my firm, and not yet a Foundation Member, I asked to become a "Special Member" of the Foundation's High School Scholarship Committee. Being able to participate in the scholarship process was remarkable and humbling. It was at this juncture that I realized I was ready to become a full-fledged Member, so that I

could formally participate in the scholarship program, enabling me to positively impact the lives of our future recipients.

Why is your work within the Foundation something you are so proud of?

To me, the CCF scholarship I received was so much more than a check; it represented the beginning of a bond between me and the Foundation. It was now my time to play a small role and repay this debt of gratitude. Over the years, it truly has been an honor and a privilege to have worked alongside my fellow Members of the Young Adults Auxiliary, the High School Scholarship Committee and ultimately the Board of Governors. Helping these young students and their families through the scholarship program made me feel so proud. Being able to meet them, interview them and hopefully change their lives for the better, is one of my most rewarding and proudest experiences. It's really the most fulfilling part of what the Foundation does. I'm proud to correct anyone who calls CCF a club - it's not a club, it's a Foundation. And at the Foundation's heart is the scholarship program and the work we do to create opportunities for the next generation.

How did your college education help define your professional career?

The ability to attend The Wharton School at the University of Pennsylvania was instrumental in shaping my career in finance. It allowed me to study business and forge connections with some of the brightest people of my generation, through which I gained awareness of career opportunities in the financial services industry that I eventually pursued, including investment banking, private equity, and public markets investing. Wharton truly was the bedrock from which I launched my career.

You are President of the Young Adults. Tell us how you came to that position within the Foundation.

When I was interviewed for my scholarship, I promised the Committee that if I was ever in a position to give back to the Foundation I would. Two years after graduating from Wharton, I was invited to a YAA recruitment night at the Foundation, which I thoroughly enjoyed. Shortly thereafter, I attended my first YAA meeting, which didn't feel like a meeting at all - it felt like a gathering of friends and family. The YAA has provided me with both an opportunity to give back as well as a whole new set of close friends in New York. It's been an honor and a privilege to serve on the YAA Board for the past four years, first as Treasurer and then as President.

You are both a scholarship recipient and now a scholarship donor – how does it feel to give back to the Foundation?

I always viewed the scholarship that I received as an investment in my future by the Foundation rather than an outright grant. I believe that every scholarship recipient has a duty to earn the Foundation an attractive return on their investment, whether financially by giving back to future scholarship recipients or by striving to promote the Foundation's ideals and mission in some other way. If you're in a position to help future generations, it's a really beautiful thing. Founding a perpetual scholarship in my grandparents' name really represents coming full circle to me it's the classic culmination of the American dream.

Why is college sponsorship more important now than ever?

The amount of financial aid that colleges and universities offer students can vary wildly from year to year. The ability to have a firm commitment from the Foundation for a set amount of scholarship funds in all four years is critical for families and students planning their futures. College scholarships are also a fantastic way for the Foundation to plant seeds for future Membership.

College Scholarship Alumna NYU Law School First Year Student

Tell us about your background, and how the college scholarship from CCF helped with your education goals.

I grew up in South-West Brooklyn and

went to public school for most of my life. I knew I wanted to attend Fordham University because I was interested in a Jesuit education, but I knew that I would have to find a way of funding my own education. So while I received financial aid from Fordham, there was a huge gap between what I received in financial aid, and what the tuition costs were. If it wasn't for Columbus Citizens Foundation, I would not have been able to go to Fordham. It was a huge deal because I was the first generation of my family to graduate from college. It was a really big deal for me to walk across the stage and get my diploma that day.

What was it about Fordham that helped you develop? What made the college experience there so special?

What I loved about Fordham is that I received individualized attention from professors that was very difficult to receive at the larger public high school I attended. I was able to have an adviser who helped me throughout my four year experience.

You recently had your pick of law schools – congratulations! Where did you end up going, and how did your college education help prepare you?

I've wanted to attend law school since I was a little girl, so to be accepted at over 30 law schools was thrilling. NYU Law School was my top choice, so I was thrilled to receive an AnBryce Scholarship. I started at NYU Law this past September and though the workload is heavy, I am thrilled to be there and feel so fortunate.

What advice would you give to young Italian Americans struggling to fulfill their true potential?

It's important to have people who give you advice and guidance, who can serve as your mentor. For many first-generation college applicants, there's a real need for advice and guidance. Drive and work ethic are vital, but you have to be willing to stand up to adversity and understand that there will be setbacks, but you have to keep pushing forward.


The brand-new Eataly NYC Downtown was the setting for the 2016 Celebration kickoff event.

Governor Cuomo gave a private reception to our Grand Marshal and Honorees, presenting them all with an official proclamation before the evening's events kicked off.

Consul General Genaurdi spoke as part of the evening's stage program and said he was honored to be present, referencing the "fantastic community" of Italian Americans in New York, without whom he said "Italy would not be the same."

Bishop Nicholas DiMarzio of the Brooklyn Archdiocese delivered the

Invocation prior to the meal, and attendees stood for performances of the Italian and American national anthems.

When CCF President Angelo Vivolo took to the stage, he spoke of how the evening represents "a great opportunity, [one that is] dedicated to the belief that helping young people get a good education will help preserve the values that are so important to us." Mr. Vivolo also remarked on how the Grand Marshal and Honorees represented the best of Italy and Italian Americans — with the three special guests reflecting the long tradition of Italian excellence in food, fashion and business.

and America. America, she said, was a place where dreams can come true, "but dreams only come true with... hard work and planning."

The focus on the dedication needed to succeed resonated in Honoree Mario Batali's speech as well. Batali said that "hard work pays off" and thanked his parents, who attended the Gala, for instilling a strong sense of culture and shared experience at the dining table when he was growing up.

Attendees of the Gala were the first to see a new video for the Foundation that featured Maria Rocco. Rocco is a widowed mother of two scholarship recipients, who was filmed reading a thank you letter she wrote to the Foundation just days before the Gala.

Anthony Massaro, President of the Foundation's Young Adults Auxiliary, is a former scholarship recipient who has gone on to gift an endowed perpetual scholarship in honor of his grandparents. In a speech from the stage, he said anything was possible with three things: "[a]relentless work ethic... personal responsibility... [and] unbridled optimism."

Grand Marshal Robert LaPenta was the last speaker of the evening, and he gave a passionate and personal speech, in which he made it clear how thrilled he was to represent the Italian-American community. He remembered seeing men wearing suits and ties in a diner with his father when he was a young boy and being told that they were business people. He said at the time to his father, "I want to do that." Mr. LaPenta praised the evening and the work of the Foundation, as he explained to the attendees that "every dollar goes to provide capable students the ability to go to a high school or college of their dreams."

The Gala was packed with exclusive live entertainment. Italian singer, stage actress, TV personality and musical theater performer, Arianna Martina Bergamaschi performed a combination of her own songs with Italian classics and had the audience

on their feet. The evening was capped off perfectly by the incredible Brian Newman Quintet, who delivered a wonderful set of jazz standards.

Overall, the Gala was a huge success, generating revenue from ticket sales,

sponsorship packages and the successful Silent Auction and Maserati Raffle. All net proceeds from the Gala go directly to the Foundation's scholarship fund.



72 YEARS OF THE COLUMBUS DAY PARADE

On Monday, October 10, the Columbus Citizens Foundation produced the 72nd annual Columbus Day Parade with over 35,000 participants and over one million spectators. Led by Grand Marshal Robert LaPenta, the Foundation's parade celebrated Italian-American achievements as it marched up Fifth Avenue from 47th Street to 72nd Street. Once again renowned broadcast journalist Maria Bartiromo and actor/radio host Joe Piscopo served as our hosts.

In addition to the crowds lining Fifth Avenue, the parade was broadcast live on WABC-7, and once again was **number one in its time period** gaining television ratings that were a **26**% **increase** over the 2015 viewers, as the parade continues to grow its television audience.

The annual New York City event is the largest Columbus Day Parade held in the United States, with all preparation and planning undertaken by the

Columbus Citizens Foundation. The parade's 2016 title sponsor was Conair Corporation, who took that honor for the third year in a row, and enjoyed full branding on our red carpet stage that was packed with entertainment. Other sponsors included Maserati, who provided a cavalcade of cars that transported our Grand Marshal, and Formaggio, who used the parade to celebrate their 25th anniversary. including Casa Building; Gabrielli Trucking; Generoso Pope Foundation; New York Community Bancorp; WCBS FM; Gabelli Funds; Country Bank; Iona College; L'Arte Del Gelato; and Wagner College.

Angelo Vivolo, President of the Columbus Citizens Foundation, said of this year's event: "Every year the parade seems to grow larger and become more celebratory. We hope the city of New York enjoys all the work that CCF puts into the event, and

that our parade can serve as a symbol for the many great accomplishments of Italians and Italian Americans and offers an event that all Americans can enjoy."

As Grand Marshal, Robert LaPenta led over 115 marching groups, 25 parade floats, 35 vehicles and over 15 marching bands up Fifth Avenue. Mr. LaPenta, Founding General Partner of Aston Capital Partners, is a driven and successful executive and philanthropist renowned for his leadership

The 2016 Parade spoke to the vitality and importance of Italians and Italian Americans in the fields of food, fashion and business with the participation of culinary trailblazer Mario Batali and visionary business leader Federica Marchionni as honorees of the 2016 Columbus Day Parade.

Spectators in the grandstand and viewers of the live broadcast on WABC-TV were treated to red carpet entertainment that began in traditional fashion with West Point Academy's Military Band and a poignant rendition of "America the Beautiful." The following acts included Italian sensation Arianna Bergamaschi; acclaimed pianist and musician Peter Cincotti and renowned jazz performer and frequent Lady Gaga collaborator, Brian Newman. "The Italian Fairy" Simona Rodano provided family fun for viewers, and in a more sobering moment of the performances, classical tenor Elio Scaccio dedicated "Con Te Partiro" to the victims of the Amatrice earthquake. Other performances included: pop acts Chetti and Sabrina

Salice; vocal performer Alyssa Lynn; The Nick Tangorra Band and choreography by Fadi Khoury's company FJK Dance.

The impact of Italy was felt throughout the parade, as the Line of March included the ANPS (National Association of Italian Police) accompanied by a Lamborghini police car flown in from Italy for the parade. Italian dignitaries marched with the Italian Consulate General, accompanied by the Corrazzieri Reggimento and two Motoguzzi (police motorcycles) also transported to New York City specifically for the day's event. Spectators also felt the culture and traditions of Italy come alive on Fifth Avenue as they watched Italian marching band Musicale Citta de Andretta performing traditional Italian songs and actor/director Massimiliano Finazzer Flory in costume as innovative Italian Leonardo da Vinci.

The parade was attended by a wide array of American and Italian politicians and dignitaries. Governor

Andrew Cuomo marched with the Foundation to kick off the Parade, and Mayor Bill DeBlasio marched alongside the FDNY with the marching band from Bishop Kearney High School nearby. Other politicians marching included Senator Chuck Schumer; Comptroller Tom DiNapoli; Public Advocate Leticia James and Congressional candidate Tom Suozzi. Many Italian dignitaries also joined in the parade including: New York Consul General Francesco Genuardi; Vice President of Chamber of Deputies Simone Baldelli and Mayor Fiorenza Pascucci of Bitetto in Puglia.

The Columbus Day Parade dates back to 1929 when New York City businessman and Italian immigrant Generoso Pope led a parade from East Harlem down to Columbus Circle. Today, the vibrant parade is planned and executed by the Columbus Citizens Foundation with the help of staff, Foundation Members and the assistance of more than twenty city agencies to deliver a safe and successful parade to New York City.





Mark L. Auriana, brother of Foundation and Board Member, Lawrence Auriana, who passed away peacefully at Memorial Sloan-Kettering Hospital on March 5.

Angelina Mackron, mother of Foundation Member, MaryAnn Tricamo, and mother-in-law of Francis Tricamo passed away in May of 2016.

Foundation Member, **Dr. Joseph P. Pizzurro** passed away on May 30 at the age of 78.

Michael Cilmi, father of Foundation Member, Desiree Cilmi-Vitali, passed away on July 2 at the age of 95. Mr. Cilmi was an attorney, World War II veteran, and lifetime Republican Party leader on Staten Island.

Gino T. Nepola, one of the Founding Members of the Columbus Citizens Foundation, passed away at 98 years old in August 2016. He was the father of Foundation Member John Nepola.

Robert Rosario Guinta II, son of Sunda Marie Guinta and the late Robert R. Guinta passed away on September 14. He grew up with the Foundation, having watched his father and mother participate as prominent Members for over 40 years.





SUPREME COURT JUSTICE ANTONIN SCALIA (MARCH 11, 1936 - FEBRUARY 12, 2016)

Justice Scalia was the first Italian
American to be appointed to the
Supreme Court in 1986. He was
appointed by President Ronald Reagan
and was confirmed by a unanimous
vote. His majority and dissenting
opinions commanded admiration and
respect for their intellectual rigor
among people from all sides of the
political spectrum. He came to be
universally revered by Italian
Americans as a source of inspiration
and pride.

Coming from humble beginnings, Justice Scalia was born in Trenton, New Jersey, on March 11, 1936. He was the only child of Salvatore Eugene Scalia and Catherine Panaro Scalia. His father, who was born in Sicily and immigrated to the U.S. as a teenager, received a Ph.D. from Columbia University and was a professor of Romance languages at Brooklyn College. His mother, the daughter of Italian immigrants, was an elementary schoolteacher.

Justice Scalia attended Public School 13 in Queens, and Xavier High School in Manhattan, where he rose to be lieutenant colonel in command of the school's marching band. He often carried his French horn to and from school on crowded rush hour trains, and he marched in many parades up Fifth Avenue.

The Columbus Citizens Foundation remains deeply honored that Justice Scalia served as Grand Marshal of the 61st Columbus Day Parade in 2005, a year when the Parade's themes were justice and human rights. At the time Justice Scalia noted, "This is the top of the hill, to be Grand Marshal in your

hometown. I marched down Fifth Avenue many times as part of Xavier High School's Regiment. For an Italian kid from Queens, there could be no greater thrill than to march one last time, as Grand Marshal of the Columbus Day Parade."


