

Since 1984, Columbus Citizens Foundation's chief philanthropic mission has been to provide scholarships to deserving students of Italian American heritage. The CCF Scholarship Program requires students are of a minimum of 25% Italian heritage and have shown success in their studies and involvement within their communities. Through the scholarship program, CCF promotes academic excellence and Italian American culture.

Program Overview and Highlights for 2021

We are grateful to you, our generous donors, who have supported CCF's mission. No matter the gift's size, you played a major role in making an impact on our scholar recipients, their lives, and supporting Italian heritage. Here are some our highlights from this year:



CCF's medical school scholarships provide funding for incoming first year medical school students for four years. We have continued our relationship with The Morgagni Medical Society, continuing to give out an annual award to a promising Italian American medical school student in their name. In 2021, The Dr. Anthony S. Fauci Scholarship was created in support of a public health medical school student. The first recipient we awarded was Danielle Rinaldi, New Jersey native and Boston College graduate.

Being the first recipient of the scholarship is deeply meaningful for Danielle. She says that the recognition that she received for all her hard work and her potential in the public health field makes her feel immensely grateful. She was awarded the Outstanding Observer award with Boston College Emergency Medical Services during her Freshman year. She also entered emergency medicine not knowing anything about being an EMT, yet it was a supportive environment for learning the critical work done by these professionals. She was also encouraged to mentor others as she gained knowledge and experience.

Here are some additional 2021 highlights:

- Approximately \$1.5 million awarded to students in 2021
- Given over \$10 million since 2001

Giambelli Foundation: A History of Giving



Francesco and Mary Giambelli Foundation is focused on cultural and ethnic awareness. Founded in 2014, the Foundation is headquartered in Woodbury, NY. Founded by famed restaurateurs Francesco "Frank" and Mary, owners and founders of Giambelli's 50th Ristorante in New York City. They were pioneers of fine dining Italian restaurants, and often hosted distinguished guests, including Pope John Paul II, and heads of state through the decades.

Often honored by their peers in the restaurant industry and the Italian American community of New York City, Frank and Mary were also known as great philanthropists, generously contributing to various organizations, including St. Vincent's Hospital, the Culinary Institute of America, and CCF's Adopt-A-Scholar program.

The over \$1.3 million in scholarship funds that have been provided by the Giambelli Foundation to CCF have provided the opportunity for 25 students to study at their schools of choice.

PHILANTHROPY THROUGH THE YEARS

The Scholarship Program is the most visible philanthropic program of Columbus Citizens, but it is far from the only efforts championed by our Foundation.



Over the years, CCF has assisted in rebuilding the Italian town L'Aquila following a devastating earthquake in 2009. In 2012, representatives of the Foundation, including former Presidents Frank Fusaro and Louis Tallarini, presented the town of L'Aquilla with a mobile police unit. The regional authorities made this specific request, to assure Italian police could continue to serve and protect the area's displaced populace.


More recently CCF contributed significantly to several campaigns in Italy to address the alarming onset of the COVID pandemic in 2020.

We similarly responded as dedicated citizens of New York City to the stabilization of lower





Manhattan following the aftermath of 9/11. As with many disasters, efforts continued for many years after the initial devastation. In 2003, Millennium High School received a \$1 million donation from CCF, allowing the public high school to open its doors to students in record time. The school was the first created primarily to serve students downtown and to illustrate



the services needed to get the residential community back on its feet in the neighborhood that was still in the throes of rebuilding efforts. Ambassador Charles Gargano, CCF Chair at that time, played an important role in brining this initiative to fruition.

The Foundation has dedicated significant resources to the preservation and maintenance of symbols of Christopher Columbus throughout the boroughs of New York City. In 1987, CCF proudly took part in NYC's Adopt-A-Monument program, raising \$400,000 for the refurbishment of New York's iconic Columbus Circle statue. Additionally, in 2007, the Foundation funded the restoration of the Columbus Bust at D'Auria Murphy Triangle in the Bronx.

In 2013, through Member support, CCF presented Cardinal Dolan with \$150,000 toward the beautiful restoration of the exterior of St. Patrick's Cathedral's.

There are many more examples of the work of the Foundation. Most importantly, through the collective compassion and generosity of CCF members, the Foundation has been an engaged civic partner in many efforts to illustrate our dedication to our cultural heritage, our love for our home city, and our desire to promote the values of the Italian American community.

The marble statue pictured opposite can be enjoyed by visitors to the second floor of the Townhouse. This lovely artwork was donated to Columbus Citizens Foundation in memory of Cav. Michael L. Santangelo, a member from 1984 to 2018, who served during this time as President and later Chair. His widow, Gr. Uff. RoseMarie Gallina-Santangelo, also a Foundation member, arranged the donation.

The sculpture was brought to New York from Italy by Michael Santangelo's grandfather on the Conte Verde in 1924. Its significance as an object and to the family is evident, as it made the journey with them to the United States. It is attributed to Luca Arrighini (1845–1915), a member of a family of well-known sculptors, very active at the turn of the century.

This figure is in the *Stile Liberto*, popular at the time. Its presence at Columbus Citizens Foundation honors the legacy of the Santangelo family and is emblematic of the links that bind the Italian American community, celebrating a shared heritage.



HOMILY

Celebrant Timothy Michael Cardinal Dolan **Homilist** Fr. Anthony Domenic Sorgie

Your Eminence, as the son and grandson of Italian Immigrants, I thank you for the honor of preaching in this Columbus Day Mass. I have attended the Mass and the subsequent parade for most of my life, and certainly with great attention from 1985-2000 when I was Professor and Director of Sacred Music at St. Joseph's Seminary and was conductor and cantor for this Mass for His Eminence, John Cardinal O'Connor.

I want to begin by asking all of you to join me in a scene on Ellis Island in the fall of 1925. A little girl sits on a bench waiting to see if her mother passed the iconic medical inspections. The little girl's name was Maria Lizette. She only spoke a little dialect, had never seen an American, let along an inspector. She passed quickly, but horror of horrors, she had to sit and watch her mother detained. And she was alone. The same eves that had just crossed the Atlantic Ocean were now riveted on an inspector and her mother. Eighty five years later, she could still talk about the eye hook that was used to raise the eye lids of everyone to make sure that there was no disease in the eyes—if they were secreting anything. Before Rosa, went for this inspection, she told little Maria to be brave 'we just came across the whole ocean, your father and brothers are waiting for you. Right there across that water, be brave.' And it paid off. Rosa passed the inspection through a second examination and she and little Maria went off to Mulberry Street. You all know where Mulberry Street is? For three days in Little Italy, and then with nothing but a couples of bags went up the brand new IRT #6 train to its final destination, Pelham Bay.

That of course was my mother Maria Lizette from Calabria. Calabria to Naples. Naples to Ellis Island. Mulberry Street to Pelham Bay. And so nine years looking out to the Tyrrhenian Sea, and 85 years listening to the 6 train rattling up the northeast Bronx. Your Eminence, in 2010, you were at my



mother's funeral 94 years old, she lived and she could describe SS Conte Biancamano—the ship she came on—at 94 the way she did at 9 years old, and like most like of those 3.2 million immigrants, at that time, she became a proud American and a proud Italian-American. With her husband Nunzio, a decorated WWII veteran in the American army, surviving the Battle of the Bulge among others, raised us to be Americans, Italians, and Italian-American and all that that meant. Typical lovers of the faith, our Catholic faith and proud of it and our country, and our country on the either side of the world whether it was from Sicily or Calabria, Salerno, Sorrento, Milano, it didn't matter. We were Americans and Italian Americans!

The deacon read, "Go, therefore into all nations baptizing them in the name of the father, the son and the holy spirit." These words of Our Lord Jesus Christ fill the letters, diaries and exchanges of Cristoforo Colombo. Evangelization of peoples was part of the promise, support and contract to the Reyes Catolicos in Spain that allowed him to make this voyage with all Spanish sailors on the Nina, Pinta, and Santa María de la Inmaculada Concepción—to give that ship its full name.

Our Lady Mary of the Immaculate Conception, travelling on that ship every place he landed he named following that first reading—do everything in the name of the Lord. First sighting 'San Salvador' – holy savior. That was not accidental. To spread the faith wherever he landed and to thank almighty God. Did you know that Christopher Columbus was a Third Order Franciscan? We don't hold that against him at all, but he was a Third Order Secular of St. Francis and it guided his life—to the end of his life. And those Franciscans made him proud; four centuries later they came here to take care of those Italian immigrants like my little Maria and Nunzio, 'whatever you do in Lord or in deed, do it in the name of Jesus'.

But the Mass and Parade today, are only partly about Christopher Columbus. They are part of Italian-American Heritage Month. We are the same and give tribute to all of those immigrants— especially today to the Italian immigrants that came and made our country here better for their coming in so many ways and they came and they came and they went and they went. Our Holy Father loves to remember that Mario Jose Bergoglio, immigrated to Argentina for the same reason. Pope Francis told the youth of Genoa, where Christopher came from, to be navigators and to have courage as he did—their native son.

Those of us that are Italian born, Italian American or Italian by adoption, all love and recognize some of the contributions that have been made by Italians and Italian-Americans. I'll give you three:

Dio Mio My god, Dio Mio La famiglia La dolce vita Dio Mio, la famiglia, and la dolce vita.

Dio Mio. Do we have to think beyond St. Frances Xavier Cabrini to think about the contribution of the many sisters, priests, brothers, friars, monks that made their way here and changed the face of American Catholicism? One little women 67 institutions San Francesca Cabrini. Sessantasette istutuzioni, ospedali, scuole. One woman! Imagine what we we could do on fire like she was! Dio mio, my God. Italian Americans, like many immigrants, took God seriously and their faith seriously.

Food and Wine. La Dolce vita. The arts, music, carpentry, jewelry, mosaics, marble. My father used to say that Italians were the best chiselers. I think he meant sculptors. They were the best sculptors. Vivaldi, Monteverdi, Bellini, Puccini,

Andrea—is there any other? Luciano, is there any other? Connie Francis—is there any other? Passion for soccer, calcio. It's the passion of dio mio is the passion of that culture. I think of, when I think of la dolce vita, I think of food. Not only pizza and pasta; though to us it was 'a-biz'. From the ruffles of Alba to the Pisachio of my native Bronte in Sicilia, we know what la dolce vita is. There's no place on the planet earth that doesn't have Italian restaurants. Mongolia to Argentina, everybody knows how to eat.

My God. My Family and this beautiful, sweet life. One small story. I wasn't very happy to be the only child some time in school who had un sacco with vitello parmigana in it. I wanted American grilled cheese! Nonna, to my Sicilan grandmother, 'Nonna, I want American bread. No crunch. Wonder Bread. I want Wonder Bread.' So she hunted in our neighborhood for a loaf of Wonder Bread. Now what's she going to do? What does she know from swiss cheese? This is the truth. She took fresh mozzarella and she cut holes in it. She made i buchi in the mozzerella e fritta. She gave it to me and said, 'Here Anthony, mangia'. So I had an American sandwich, soggy with olive oil and mozzarella with holes in it. Very ingenious, the Italiani. Very ingenious.

We continue this Mass and this celebration today to celebrate those three things-faith, family, and the beauty and the genius of Christopher Columbus, Michelangelo, DaVinci, Vivaldi, of people like Lidia Bastianich and those that give us and continue to give us la dolce vita. And our faith.

In Sicilian, we have many proverbs and I have to give you one in the native tongue, Lu Signiuruzzu Ii cosi, Ii fici dritti, vinni Iu diavulu e Ii sturciu. God makes things straight; we make them crooked. That's true. So, capturing all the dreams, all the exploration, all the wonder, all the discovery that immigrants needed and the discoverer needed, we praise almighty God today for all of them, but especially our faith. For our families and the sweet life that continues to be human genius.

COLUMBUS DAY PARADE RETURNS TO FIFTH AVENUE FOR 77TH ANNUAL PARADE

On Monday, October 11, the 77th Annual Columbus Day Parade was held in New York City. The Parade celebrates Italian American culture and achievements and is the largest celebration of Italian heritage in the world. Grand Marshal Michael Pascucci, Chairman of Duck Pond Associates, led the Parade. This year's event marked a return to Fifth Avenue, as COVID-19 restrictions saw 2020's festivities celebrated virtually. The excitement of returning to a live parade was palpable, and Italian-American pride was evident to all those who watched the Parade live on ABC-7 or lined Fifth Avenue to attend in person.



TOM GOLISANO NAMED GRAND MARSHAL OF 2022 COLUMBUS CELEBRATION,

WILL LEAD NYC COLUMBUS DAY PARADE ON OCTOBER 10TH

NEW YORK – Thursday, May 12, 2022 – Columbus Citizens Foundation announced today that Tom Golisano, founder of Paychex and noted philanthropist, will serve as the 2022 Grand Marshal of the Columbus Day Parade on New York City's Fifth Avenue. Golisano's visionary business acumen led to the creation and success of Paychex, which streamlined payroll and human resources services to businesses nation-wide. Golisano is also an investor in 18 businesses across the country. Golisano's charitable work is undertaken by the B. Mr. Golisano is the founder of Paychex, Inc., a leading provider of integrated human capital management solutions for payroll, benefits, human resources, and insurance services. Tom Golisano served as Paychex's president and chief executive officer from 1971, when he founded the company, until October 2004, when he retired from his position as president and CEO. Golisano served as Board Chairman for the last 17 years. With more than 50 years of industry expertise, Paychex has 16,000 employees, serves almost 700,000 clients in the U.S. and Northern Europe, pays one in 12 U.S. private-sector employees, and is the largest HR company for small to medium-sized businesses. It is headquartered in Rochester, New York.

Mr. Golisano and Paychex have consistently been recognized by business, financial and national media. Mr. Golisano was listed among the FORBES top 10 bosses in the U.S. for three consecutive years; the annual ranking is based on chief executives who provide the best balance between their compensation and shareholder return.




SANDRA TOBIA
